2021 Open Enrollment Fact Sheet

Age 65+ (Medicare) Retirees/Beneficiaries: READ THIS FIRST!

This year's Open Enrollment is September 21 – October 9, 2020. Open Enrollment is the time when retirees/beneficiaries can review, elect or decline coverage, or make plan changes for the upcoming plan year. After Open Enrollment, you can change your coverage during 2021 **ONLY** if you have a qualifying life event (e.g., marriage, divorce, birth of a child).

Benefit Changes Effective January 1, 2021

Health plan **premium changes** for 2021:

- There will be no change to the premiums for the Basic or Enhanced Aetna Medicare Advantage plans.
- Anthem Medicare HMO Plan: 1.4% increase
- Anthem Medicare Indemnity Plan: 1.4% increase
- Anthem PPO Plus Plan: 1.4% increase
- Aetna Dental Plans: No changes
- EyeMed Vision PPO Plan: 13.4% decrease

YOUR 2021 PLAN OPTIONS

Six medical plans:

- **NEW!** Kaiser Senior Advantage Plan
- Basic Aetna Medicare Advantage Plan
- Enhanced Aetna Medicare Advantage Plan
- Anthem Medicare HMO Plan
- Anthem Medicare Indemnity Plan
- Anthem PPO Plus Plan (available only to those currently enrolled in this plan)

Two dental plans:

- Aetna Dental PPO Plan
- Aetna Dental HMO Plan (you must choose a primary care dentist—see your enrollment packet)

One vision plan: EyeMed Vision PPO Plan

What Do I Need to Do?

1. If you are **NOT** in the Basic or Enhanced Aetna Medicare Advantage Plan for 2020 and want to enroll in either plan for 2021, you **MUST** have Medicare Parts A and B. **To enroll, you must call Aetna at 800-307-4830 by October 9, 2020.** You will receive a confirmation number; keep this number for your records.
2. If you are currently enrolled in the Anthem Medicare HMO Plan and you have Medicare Parts A and B, you will be enrolled automatically in the Basic Aetna Medicare Advantage Plan. Your coverage will start January 1, 2021. If you don't want Basic Aetna Medicare Advantage Plan coverage, you must call Aetna at 800-307-4830 by October 9, 2020 to opt out of this coverage. **If you don't want Aetna Medicare Advantage Plan coverage, you must opt out EVERY year, even if you opted out for the current year. If you are married, you and your spouse must call Aetna separately to opt out.**

Note: There will **NOT** be a second opt-out period.

3. **ALL** Medicare-eligible retirees/beneficiaries must complete the *2021 Part B Affidavit* to certify their Medicare Part B coverage. Completed affidavits must be returned to the Pension Office, postmarked by October 9, 2020.

If you don't return the *2021 Part B Affidavit*, with a copy of your Medicare card, you will lose the Medicare subsidy currently provided to you by the County for 2021.

Open Enrollment Meetings
