The Fulton County Employees' Retirement System Defined Benefit Plan Board (Pension Plan) has called an election for **One (1)** <u>Retiree</u> member of the Board. The election will be held:


#### Tuesday, May 28, 2024 through Friday, June 14, 2024.

The candidate receiving the most number of votes in this election will serve on the Board for a four-year term expiring June 30, 2028. The position requires attendance at the regular monthly Pension Board meetings and other assigned Committee meetings. The person filling this position, if a first-time Trustee, will also be required to complete 8 hours of education in various applicable areas within a 14-month period, starting July 1, 2024, or if a previous-serving Trustee, must complete a minimum of 12 hours of education every 26 months, per the FCERS Board Member Training Policy and State law (*O.C.G.A. §47-1-17*). The regular monthly Pension Board meetings are normally held on the second Wednesday of each month, with Committee meetings taking place before the Pension Board meeting.


All persons who are receiving a pension benefit from the Fulton County Employees' Retirement System Defined Benefit Plan (DB) and wish to be a candidate for this position must file a <u>Notice of Candidacy</u> with the Executive Secretary, Fulton County Finance Department, 141 Pryor Street, Suite 7001, Government Center, between start of business, Friday, April 19, 2024 through close of business, Friday, May 3, 2024.
