ELECTRONIC PAYMENTS REQUIREMENT COMING SOON

All Fulton County Defined Benefit Plan retirees/beneficiaries will be required to receive their monthly payments electronically either through direct deposit OR pre-paid debit pay card. In an effort to ensure that retirees are paid timely in the event of any unforeseeable circumstances including the Coronavirus pandemic (COVID-19), the County will discontinue normal processing of paper manual paper checks soon. Retirees currently receiving

paper checks and new retirees will have the option of direct deposit OR pre-paid debit pay card. Retirees currently receiving paper checks will receive a letter in the mail with more detailed information and instructions on the two pay options in the next few weeks.



IMPORTANT RETIREE SELF-SERVICE (RSS) INFORMATION PAPERLESS "GREEN" INITIATIVE

We highly encourage you to access the RSS portal as Fulton County is considering going paperless where you will no longer receive your paper pay advices in the mail. The Retirement Self Service (RSS is a new online service to help you access important information about your retirement benefits. The RSS system will allow you to view/access personal information, such as monthly pension pay advices, benefits summary, current tax withholding/allowances, pay and deduction summaries, and 1099R forms. You can also access important forms and reference guides, such as address changes, direct deposits and tax withholdings. All of this information is now available in a secure online service! In order to access your information on the RSS portal, you will have had to opt into the service by submitting your email address to the pension office. If you have not, don't worry! You can still submit your information for roll-out scheduled for July 15, 2020! To enroll, please provide us your email by simply sending an email with "RSS" in the subject line and your first and last name in the body to pensionunit@fultoncountyga.gov.

TELEHEALTH

Fulton County is committed to the health and well-being of retirees and beneficiaries. In light of the Coronavirus (COVID-19), the County would like to remind you to take advantage of the telehealth/virtual doctor visits option available through your medical providers as a safe, secure and convenient and effective option for members to see a doctor to receive health care guidance in an effort to limit potential exposure in physician offices, as necessary.

Aetna Basic and Enhanced Medicare Advantage Plan Members:

Aetna will offer zero co-pay telemedicine visits – for any reason through June 4, 2020. Cost sharing will be waived for all virtual visits through in-network providers delivering synchronous virtual care (live videoconferencing). Through Aetna's Healing Better program, members who are hospitalized with COVID-19 will receive a care package containing CVS items to help relieve symptoms. Aetna is offering resources to help address any associated anxiety and stress related to COVID-19 including opening Crisis Response Lines and expanding access 24x7 to the Aetna Nurse Medical Line, among others: Crisis Response Line 1-833-327-AETNA/ 1-833-327-2386; 24/7 Aetna Nurse Medical Line 1-800-556-1555. Anthem (BCBSGA) Plan Members/LiveHealth Online:

Regardless of the medical plan option you choose—or even if you don't choose Fulton County medical plan coverage— you and your eligible family members will have access to Anthem's telehealth provider, LiveHealth Online (Cost sharing will be waived for Anthem members using LiveHealth Online through June 16, 2020; co-pays for physical and behavioral health conditions will also be waived. Non-Anthem members pay \$59 per visit). Just enroll online at www.livehealthonline.com or on the free mobile app available on Apple App or Google Play Store. With LiveHealth Online, you get: 24/7 doctor visits through live video from the comfort of your own computer or mobile device with internet connection. Your choice of U.S. board certified doctors through private, secure online visits. The 24/7 nurse line is always available for you to speak to a registered nurse regarding any health concern. Call (800) 724-2583 for the Nurse line. For member services call (800) 474-2227 or visit www.anthem.com. Also if you think you have COVID-19 symptoms, Sydney Care can help. Check your potential risk quickly with the 24/7 Sydney Care mobile app. Visit www.anthem.com/coronavirus to learn more. Anthem will waive cost shares for members of our employer-sponsored, individual, Medicare and Medicaid plan members— inclusive of copays, coinsurance and deductibles—for COVID-19 test and visits to get the COVID-19 test.

Kaiser Permanente Plan Members:

Kaiser Permanente's Video and Telephone Visits is available to Kaiser members only. To get started register on www.kp.org or on the free mobile app available on Apple App Store or Google Play Store. You can also schedule an appointment by phone by calling (404) 365-0966 and ask for a Video Visit or Telephone Visit.

Some of the features include: No copay or additional charge for a Video Visit from Kaiser, in most cases. Meet face-to-face online with a doctor on your computer, smartphone, or tablet for certain minor conditions or follow-up care (To schedule, you must be 18 years or older and have seen your doctor in the past year, these features are available when you receive care at Kaiser Permanente facilities. Check with your doctor's office to find out if video visits are available to you). Call (404) 365-0966 to get 24/7 care advice/guidance; get medical advice from a Kaiser Permanente provider. INFORMATIONAL UPDATE ANTHEM (BCBSGA) MEDICARE SUPPLEMENT PLANS

Medicare Coordination of Benefits

When Medicare is identified as the other coverage, the order of benefits has to be determined. Actively-employed members will maintain their group insurance as primary once they become Medicare eligible. However, once they retire, Medicare will become primary, and their Anthem BCBSGA coverage as secondary. If you are covered by other insurance(s), in addition to BCBSGA plan and Medicare, please contact Customer Service to obtain additional information regarding your coordination of benefits. The actual coordination may differ depending on other criteria pertaining to the other coverage.



WHAT ARE THE DIFFERENT PARTS OF MEDICARE?

- Medicare Part A covers inpatient hospital care, skilled nursing, hospice care and other services;
- Medicare Part B covers doctors' fees, outpatient hospital visits, other Medical services and supplies that are not covered by Part A;
- Medicare Part D Prescription Drug Coverage.

Medicare Part B Eligible Retirees, Beneficiaries and Dependents

If you are a Medicare eligible retiree, beneficiary or dependent spouse eligible for Medicare Part B coverage and choose not to purchase it, your Anthem BCBSGAGA policy will only pay as secondary to Medicare even if you do not elect Part B.

 Medicare Part B is a voluntary program; individuals are not required by law to enroll in Part B. Notification to enroll in Medicare Part B and assessment of any late enrollment penalty is administered directly by Social Security. Retirees/beneficiaries enrolled in

Medicare Part B and provide proof of their Part B enrollment are eligible for the County provided subsidy amount equal to one half of the base Medicare Part B rate. Under the County's Plan, when a retiree or their spouse becomes eligible for Medicare Part B and/or



at age 65, Medicare automatically becomes your primary insurance carrier and the County's medical plan is secondary. The Anthem plan supplements benefits paid by Medicare. Anthem will assume secondary payer status when an individual is eligible for Medicare Part B. Retirees who do not elect to Participate in Medicare Part B will be responsible for payment of the balance of their medical expenses beyond those covered under the County's medical plan. Eligible retirees and dependents who are not participants in Medicare Part B will be responsible for payment of the balance of their medical expenses beyond those covered under the County's medical plan. It is highly recommended that Medicare eligible individuals consider whether enrollment in Medicare Part B is advantageous to them.



PRE-65 (NON-MEDICARE) RETIREES EARN/KEEP 2020 WELLNESS CREDIT

Pre-65 (Non-Medicare) retirees and beneficiaries can take advantage of County sponsored on-site biometric screenings in order to keep/earn your 2021 annual \$240 wellness credit. Beginning in June 2020, Anthem (BCBSGA) and Kaiser Permanente will be on-site at various locations conducting biometric screenings for employees, retirees/ beneficiaries wish to participate in the screening – see respective schedules are below. 
URGENT CARE VS EMERGENCY ROOM — WHICH IS BETTER FOR YOU?

MASS MUTUAL WILL REPLACE TIAA AS THE 457(B) DEFERRED COMPENSATION ADMINISTRATOR

WHY THE CHANGE? The Board of Commissioners approved the change in service provider of the 457(b) Deferred Compensation Plan from TIAA to MassMutual. The County went through a formal request for proposal (RFP) process to solicit vendors to perform the services needed and Mass Mutual was selected as the most suitable administrator because they scored the highest on the technical component of the RFP and

the lowest on cost. TIAA did not respond to the RFP.

WHAT HAPPENS TO YOUR MONEY? If you have funds at TIAA, the transition requires a period during which your account balance will transferred/mapped into funds with similar investments. We're committed to giving you the resources you need to make informed choices during the transition. A newsletter with the details on the transition process is forthcoming.

CORONAVIRUS AID, RELIEF & ECONOMIC SECURITY (CARES ACT) UPDATE

The Coronavirus Aid, Relief, and Economic Security Act (CARES ACT) provides three direct inclusions that immediately expand the usage of health savings accounts (HSA): (1) Telehealth services can now be covered pre-deductible under a High Deductible Health Plan. The end date of this provision is Dec 21, 2021. (2)Over the counter (OTC) drugs and medicines are now eligible for reimbursement from an HSA, FSA or HRA. This is a permanent change. (3) Menstrual products are now eligible for reimbursement from an HSA, FSA or HRA. This is a permanent change.

The first cases of COVID-19 in Georgia were reported in Fulton County on March 2, 2020. Since that time, the virus has continued to spread and has rapidly changed our daily lives.
